**Christy Hall** – a new sign is awaited for the Hall. The car park work has been completed. A trellis was requested on the new fence but the Hall Committee is not prepared to provide this but has agreed that the resident on the opposite side of the car park has the authority of the Hall Committee to erect the trellis at his personal cost.

**Environment** – The Chair proposed that the Council look at erecting "Gateway signs" at each end of the village along the Basingstoke Road. The Clerk had provided the Chair with a recently received advertising booklet. The chair will arrange on site meeting to which Councillors will be invited to discuss this project.

Stream on the Green. Concern was expressed that the banks along the stream had not been cut back and this stopped parishioners getting close to the stream.

The Clerk was asked to contact Enviroaqua to arrange an on site meeting with Nicholas Gibbs to discuss the current contract of two visits to cut the stream each year in June & October.

**Highways and Byways.** The trees requiring attention in Kiln Lane are still on the list of highway issues but so far no action has taken place. These trees are on the highway.
